NEW BUSINESS

John proposed a motion that we should buy our insurance through Chris Robinson when the policy comes up for renewal in August. Judy seconded the motion. Carried.
- Ticket Sales for Events John reported that with regard to the pub night Carol Kranenburg and Pat Black did, about 10 people backed out at the last minute. It was suggested that in future tickets be sold in advance to avoid this problem.

Preston made a motion that the meeting be adjourned. Bob seconded the motion. Carried.
